Substantive Statement of Need:

EWU is the only Washington State institution that offers a BME endorsement. There is great potential to increase program enrollment by extending our reach across the state via the use of online and other distance education technologies. Current course requirements (28 credits) will be converted to a mix of online and hybrid courses with significant reliance on online and other distance education technologies under a self-support model. The first cohort will begin study in Fall 2011.

This endorsement certificate provides a unique and important contribution to future business and marketing educators and students in the State of Washington in the following ways:

- FBLA (Future Business Leaders of America) and DECA (international association of marketing students) are state and national student leadership organizations (CTSOs) and appear in most high schools in Washington State. These programs are run by certified BME teachers.
- High school students take CTE course offerings within business and marketing CTE departments.
- High schools hire BME teachers for these classes; and without BME credentialing, a teacher is not allowed to teach any of these courses.
- BME credentialing requires the completion of the BME endorsement certificate in addition to paid work experience in this field, a four-year degree with a residency certificate, and the West E national exam in business and marketing. The endorsement-granting institution verifies completion of all requirements.
- By converting EWU's existing BME courses to hybrid and online courses, any
 potential candidates throughout the state can have access.
